ANNEX E: QUALITY POLICY STATEMENT

Quality Policy **Mauritius Accreditation Service (MAURITAS)**

We, the national Accreditation Body of Mauritius, have been established as a department under the Ministry responsible for the subject of Industry since 1998.

The main objective of our office is to provide a national, unified service for the accreditation of Conformity Assessment Bodies (CABs) such as Calibration and Testing laboratories, Inspection Bodies and Certification Bodies to confirm that they are operating in a competent, consistent and impartial manner.

Our Management System is made up of policies and procedures which are based on the requirements of *ISO/IEC 17011 Conformity assessment – Requirements for accreditation bodies accrediting conformity assessment bodies* and to any additional requirements laid out by Global Accreditation Cooperation Incorporated (Global ACI), African Accreditation Cooperation (AFRAC) and Southern African Development Community Cooperation in Accreditation (SADCA).

We commit to maintain our signatory status to the Multilateral Mutual Recognition Arrangements (MRAs) of Global ACI, AFRAC and SADCA and promote same to all stakeholders.

We target to offer accreditation services that will be directly beneficial to the users of conformity assessment activities and to Mauritian enterprises in particular, in enhancing the competitiveness of their goods and services both on the national and international market.

All our stakeholders are encouraged to channel their views through the MAURITAS Advisory Council.

We ensure, through all our staff, that our services are constantly of the highest quality and of benefits to all our clients without discrimination. In addition, MAURITAS undertakes to show transparency, competence and independence in the delivery of its services.

All MAURITAS staff including the MAURITAS Advisory Council, of the Accreditation Committee, of the Technical Advisory Committees, assessors and technical experts are required to familiarise themselves with the relevant policies and procedures of the MAURITAS management system.

All MAURITAS staff undergo an induction training on the MAURITAS management system. By signing their job description, MAURITAS staff agree to implement the policies and procedures developed. MAURITAS maintains the suitability of its management system through the annual internal audits and management reviews.

The Director has the responsibility to implement the MAURITAS Quality policy. Performance Indicators with Measurable Targets are set annually.
